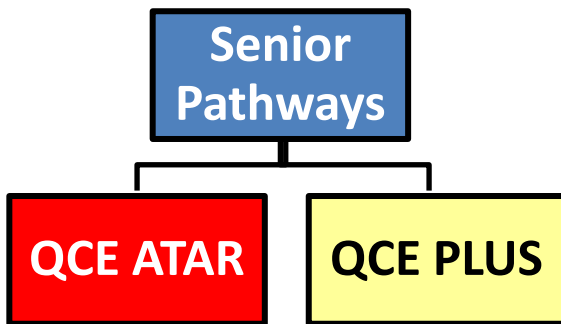




Year 11 CURRICULUM OFFERINGS 2019

as at 13 August 2018



There are **two** main educational pathways at Centenary SHS in the Senior Phase of your learning. When you choose to enrol in Year 11, you must accept that:

1. School is your **No 1** job
2. QCE is your **core** business – not negotiable
3. You must choose **one (1) pathway**

Students must choose six (6) subjects as part of their educational pathway.

1. QCE ATAR Pathway (Aiming for direct university entrance)

If you definitely want to go to university, choose an ATAR (Red). You need to choose at least four (4) General Subjects and two (2) other (Applied Subject or Certificate III, IV or Diploma).

It is highly recommended that you be achieving at an average 'A' or 'B' overall level of achievement in Year 10. You must be prepared to study at least three (3) hours per night in Years 11/12.

Strong Advice: If you want an ATAR, we do not suggest you are absent for any part of the day or week (e.g. attending TAFE certificate course). Concentrate on your General Subjects or undertake VET study offered through the school.

2. QCE PLUS Pathway (Further Education & Training, Work or Other)

Who should consider this Pathway?

If you do not require an ATAR and have an average of 'C's' on your report card, we strongly advise you to undertake the QCE PLUS Pathway alongside the QCE. You should consider any combination of the following:

1. Enrolling in a Vocational Education course, such as Prevocational (Certificate I or II) either at school or through TAFE
2. Enrolling in a Certificate III, IV or Diploma course at school or through TAFE
3. Studying Applied Subjects (listed page 2)
4. Undertaking a SAT (School-Based Traineeship or Apprenticeship)
5. Other pathways to university

Why complete a Certificate III, IV or Diploma?

A completed School-Based Traineeship and/or Apprenticeship will also contribute QCE credits. Qualifications such as the AMEB will also contribute credits toward your QCE.

A Certificate III, IV or Diploma **may** allow you to compete for tertiary entrance on a direct entry basis, however this will depend upon the institution. Check that you have met the "Prerequisite Subjects" for each university as outlined on the QTAC website (<https://www.qtac.edu.au/>)

Successful completion of a Certificate III, IV or Diploma may also lead directly to employment and/or further education and training through TAFE.

Why undertake a Prevocational course?

Prevocational courses include Certificate I or II qualifications that lead to trade-based Traineeships and Apprenticeships. Prevocational qualifications are generally undertaken through Brisbane TAFE (Skillstech) one day a week over a 12 – 18 month period. It is strongly recommended that students interested in this pathway undertake the 'Trade-Taster' program at Skillstech TAFE in Term 3 Year 10 **and** ensure they have met all requirements for enrolment by the due dates (usually in September this year). Please refer to the Transition Coordinator for further information.

Flexible Study Options

Please note that students may access prevocational courses (e.g. Electrical, Hairdressing, Construction) and other TAFE programs (Certificate III level and above) with a variety of outside organisations. These will need to be negotiated through the Senior Schooling HOD or Transition Coordinator as part of your SET Plan.

Those students undertaking courses outside of school may be eligible to reduce their school program by one subject. ATAR eligible students are not able to undertake flexible study options as part of their pathway.
